NOTICE

The Institute has notified the conduct of screening test in various departments for faculty recruitment at Assistant Professor G-II, L-10 level. In this connection following instructions/guidelines are notified for all eligible candidates:

- 1. The screening test is being conducted to shortlist the candidates for interview. There shall be no weightage to the score/merit of the screening test for the purpose of selection.
- 2. The screening test shall be on Multiple Choice Question (MCQ) pattern with 60 questions to be attempted in 90 minutes. Each right answer shall have 04 marks and there shall be (-1) negative mark for each wrong answer.
- 3. The minimum cut-off score shall be 30 marks for UR candidates and 27 marks for reserved categories. Only those candidates who have scored more than the cut-off score shall be considered for preparation of the shortlist for interview on the basis of merit.
- 4. The candidates shall be called for interview in the ratio of **1:5** (1 Vacancy: 5 Candidates).
- 5. Thermal screening of the candidates shall be done at the entry points of the test center.
- 6. The candidates without mask and not adhering to the COVID-19 prevention protocols shall not be allowed to enter the test center/s.
- 7. The candidates in their own interest are advised to report at least 1 Hour earlier than the scheduled time of screening test. No candidate shall be allowed to enter the test center 15 minutes after the commencement of the screening test.
- 8. The candidate appearing in the screening test must have a Proof of Identity issued by Government (in original) such as Employment Card, Aadhar Card, Passport/Driving License/PAN CARD/ Voter Card etc. without which candidates

will not be permitted to appear in the screening test. No Photocopies of the above documents shall be entertained.

- 9. The use of digital gadgets mobile phones etc. in the examination hall is strictly prohibited. The candidates are advised **not** to carry any such item/equipment in the examination hall. If anyone is found to be in possession of any prohibited items/equipment in the examination hall, his/her candidature shall be cancelled and he/she can be barred for applying against any future recruitment advertisements in the Institute.
- **10.** The use of Non-Programmable scientific Calculators is allowed in the examination unless otherwise prohibited through instructions in the question paper.
- 11. The Examination Centers will implement the Social Distancing and other measures as per Government of India guidelines in current scenario of Covid-19 to ensure health and safety of the candidates and staff on duty.
- 12. The candidates are also required to adhere to the guidelines and maintain the Social Distancing and hygiene to ensure safety of their own health and of the fellow candidates.
- 13. The candidates in their own interest are advised to regularly visit the Institute website for further updates. All recruitment related updates shall be uploaded on the Institute website only.
