- 2. The fee will be charged uniformly and no concession shall be given to any category.
- 3. In view of present Covid-19 pandemic, in case a candidate is short of any document / certificate, he / she shall be allowed to register for the programme provisionally against an affidavit issued by 1<sup>st</sup> class Magistrate to the effect of the same pending document be submitted in original within a period of one month.
